

FAMILY PENSION

Broad provisions relating to family pension

Under subrule (20) of rule 22 of All India Services (Death-cum-Retirement) Rules, 1958, family for the purpose family pension means :

- (i) wife in the case of a male Member of service, or husband in the case of a female member of service;
- (ii) a judicially separated wife or husband, such separation not being granted on the ground of adultery and the person surviving was not held guilty of committing adultery;
- (iii) unmarried son who has not attained the age of twenty-five years and unmarried or widow or divorced daughter, including such son and daughter adopted legally;
- (iv) dependent parents;
- (v) dependent disabled siblings (i.e., brother or sister) of a member of service.

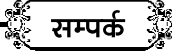
Under subrule (7) the period for which family pension is payable :

- (i) in the case of an unmarried son, until he attains the age of twenty-five years or until he gets married or until he starts earning his livelihood, whichever is the earliest.
- (ii) in the case of an unmarried or widowed or divorced daughter, until she gets married or remarried or until she starts earning her livelihood, whichever is earlier;

If the son or daughter of a member of service is suffering from any disorder or disability of mind including the mentally retarded or is physically crippled or disabled so as to render him or her unable to earn a living even after attaining the age of twenty-five years, the family pension shall be payable to such son or daughter for life.

- (iii) in the case of parents, who were wholly dependent on the member of service immediately before the death of the member of service, for life;
- (iv) in the case of disabled siblings (i.e., brother and sister) who were dependent on the member of service immediately before the death of member of service, for life.

These are broad provisions. For details see rule 22 of the AIS (DCRB) Rules, 1958
